

# LOVELESS CAFE 65th BIRTHDAY BISCUIT BASH GIVEAWAY RULES & REGULATIONS

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**ELIGIBILITY:** The Loveless Cafe 65th Birthday Biscuit Bash Giveaway (the “Contest”) is open only to legal residents of the state of Tennessee who are 18 years or older at the time of entry and whose workplace lies within a 50 mile radius of the Loveless Cafe. Void where prohibited or restricted by law. You need not be present to win. Employees (and their parents, spouse, siblings, children and/or others living in the same household) of The Loveless Cafe, GP (the “Sponsor”), and its officers, directors, members, affiliates, agents and advertising, promotional and/or judging agencies are not eligible to enter or win.

**HOW TO ENTER:** The Contest will begin at 12:00 pm, CST on Monday, March 7, 2016 and end at 11:59 pm, CST on Monday, October 31, 2016 (“Contest Period”). During the Contest Period, you may enter the Contest via the Internet by logging on to <http://www.lovelesscafe.com/> and following the entry directions. You may be required to register or to otherwise provide some or all of the following information: Your full name, place of work, work address, city, state, zip code, telephone number, birthdate and email address. Entries are limited to one (1) entry per participant during the Contest Period. Multiple participants are not allowed to use the same email address. Any attempt by a participant to acquire more than one (1) entry by using numerous email addresses, registrations, identities, or any other methods will void that participant’s entries and that participant may be disqualified. The use of automated software or computer programs to register or enter the Contest is prohibited, and any individual who uses or attempts to use such methods to register or to enter will be disqualified. Valid entries must contain all information requested. Incomplete and/or multiple entries will be disqualified. Should multiple users of the same email account or mobile phone number, as applicable, enter the Contest and a dispute thereafter arises regarding the identity of the participant, the authorized account holder of said email account or mobile phone account at the time of entry will be considered the participant. “Authorized account holder” is defined as the natural person who is assigned an email address or mobile phone number by an Internet access provider, online service provider, mobile service provider or other organization which is responsible for assigning email addresses, mobile phone numbers or the domain associated with the submitted email address. The Contest winner will be selected from online entries only. The Sponsor will not verify receipt of entries. In addition, the Contest Winner will be awarded an additional prize from the Loveless Cafe with an approximate retail value of \$50. Grand Prize must be redeemed within thirty (30) days of notification. Delivery must be scheduled Tuesday through Thursday, 9:00 am to 5:00 pm, to Winner’s workplace within 50 miles of the Loveless Cafe: 8400 Highway 100, Nashville, Tennessee 37221.

**RANDOM DRAWINGS:** A total of one (1) Grand Prize Winner will be selected on or about the first of each month in the Contest Period, starting with April, by judges selected by Sponsor, whose decisions are final and binding in all matters relating to this Contest. The Grand Prizes are guaranteed to be awarded. The Winner will be notified by telephone or email. Non-winning entries each month will carry over into the remaining drawings. Once an individual is named a Grand Prize Winner, other entries from the same physical workplace are ineligible to win future prizes in this Contest.

**PRIZE CONDITIONS:** No substitution for the Grand Prize will be permitted. If necessary due to the unavailability of the Grand Prize, a prize of equal or greater value will be awarded at the discretion of the Sponsor.
